Demand Drafts (Only INR Demand drafts are accepted):

Two separate demand drafts are to be made:

- 1) **Visa Fee:** Bank draft made in favour of **MBIE**. Please refer to the [Immigration New Zealand website](#) for information on how to pay the relevant visa application fee
- 2) **Service Fee:** Bank draft in **INR only** made in favour of **TT Services** payable at the local branch where the application is lodged.

Bank Transfer (Applicable only for applications submitted from outside India):
